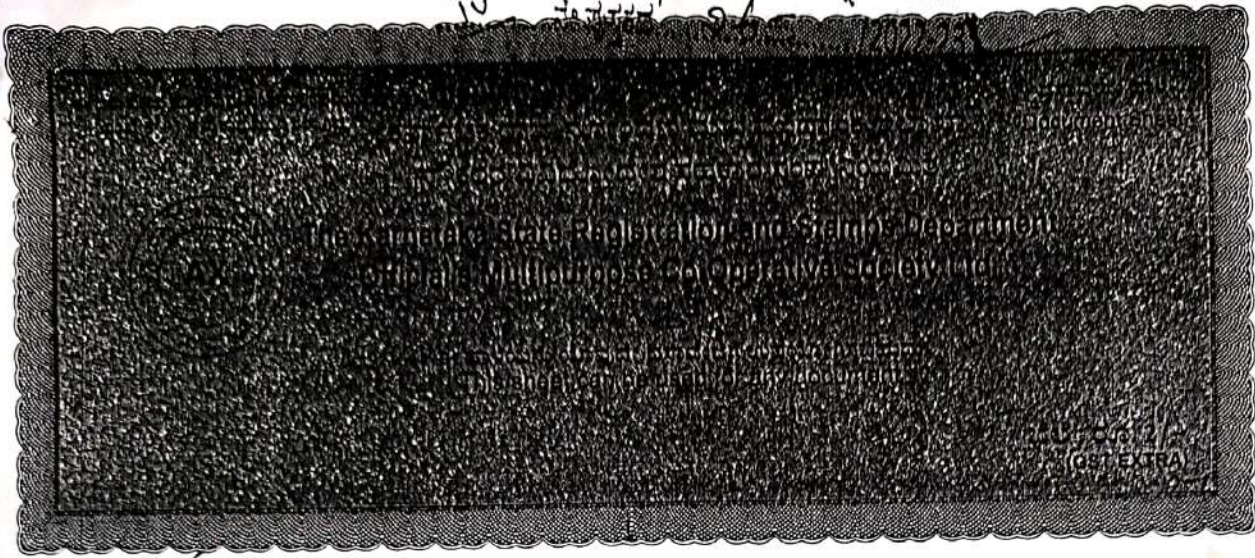



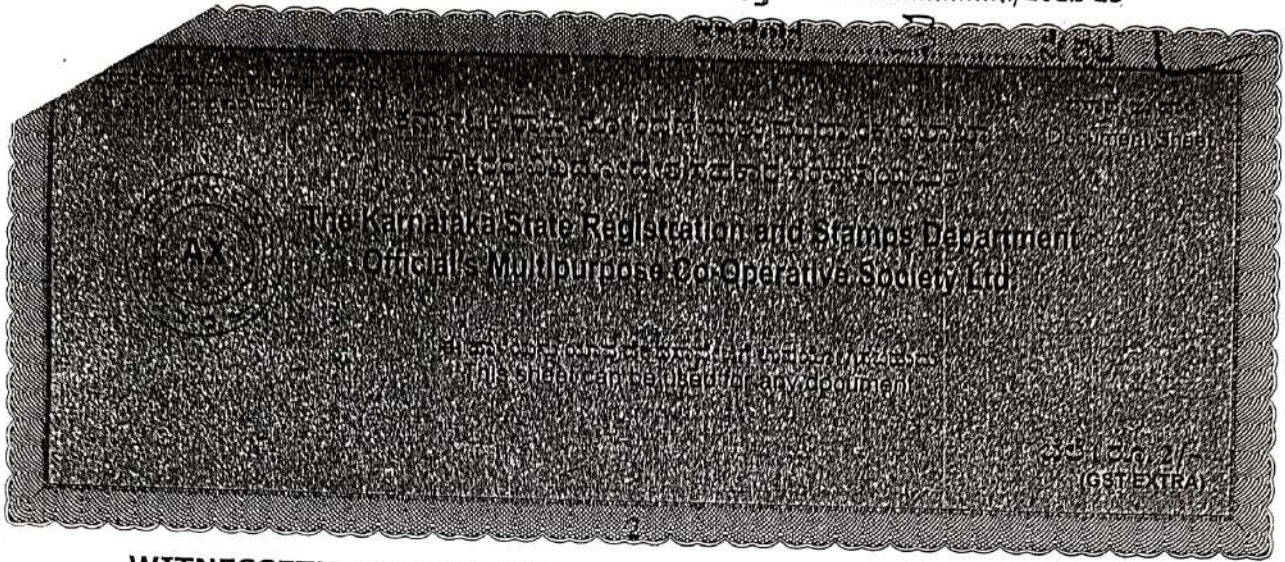

**WITNESSETH AS FOLLOWS**

**WHEREAS**, Originally the Trust was founded/constituted by Four persons/Trustees namely (i) Smt. Roopa Srinivas W/o. Srinivas H.A., (ii) Smt. Swetha N., W/o.Gopinath M.,(iii) Sri. Srinivas H.A., S/o. Late H.C. Anjinappa & (iv) Sri. Gopinath M., S/o. Late T.R. Munishamanna, had constituted a trust under the name and style of **"THE RISING EDUCATIONAL TRUST"**, formed by Registered trust deed dated 12.02.2020, Registered vide Document No.HSK-4-01220-2019-20, stored in CD No.HSKDD961, which was registered in the Offices of the Sub-Registrar, Hosakote.

**WHEREAS**, the above said four Trustees are the founder Trustees of the Trust and now Smt. Swetha N., W/o.Gopinath M., & Sri. Gopinath M., S/o. Late T.R. Anjinappa, to do all acts without altering the intention and objectives of the Trust and they had resigned from the Trust and their resignation was accepted on 30.06.2022 in the Board Resolution.
